

Reclaration of Overseer



NOTICE TO THE PUBLIC

The date of its Creation being On this Eighteenth Day of the Eighth Month in the year commonly known as Two Thousand Twenty-Three.

LET IT BE KNOWN TO ALL PRESENT that **Russell Paul Arthur a Sovereign Man from the House of Bishop** (hereinafter "Overseer") has accepted to hold the Order of Overseer (hereinafter "Order") for GRACE SOCIETY (hereinafter "Society") an Aliveration Sole and Eleemosynary Society.

Through a Private Instrument and Articles of Creation and Establishment Russell Paul Arthur has been Qualified and Ordained to said Order, and he has accepted the Authority and duties thereof and subject to the following conditions:

ORDER OF OVERSEER

- 1. The Order is a private contract between the Overseer and the Divine Source of Creation, and therefore an Eternal Covenant that no man, woman, or institution can intervene upon or controvert, and therefore shall remain free of ALL impairments or intrusions.
- 2. The Order is established with a line of succession and therefore is perpetual in nature and can never be dissolved or cease to exist.

- 3. The Order is established as a Sovereign Body on the substance of Earth and within the Jurisdiction and Venue of the NATURAL JUSTICE ALLIANCE (hereinafter "Justice") for the Society, and therefore that stands superior to any man-made purported claim of venue and jurisdiction.
- 4. ALL substantive, inherent, unalienable, and equitable rights are expressly preserved and protected under the Protections and Immunities thereof, and whereby:
 - a. In conformity with this Order, no other Earthly, Worldly or Universal Authorities in ALL existence – be it real or fictional entities, can ever have authority over the Order. This order does not attach to or grant or impute or adhere to ANY and ALL authorities of jurisdiction.
 - b. This Order stands separate from and superior to ALL lesser constituted jurisdictions.
 - c. The Order does not recognize, acknowledge, receive, or accept any alleged or purported jurisdiction of the aforsaid authorities.
 - d. The Order does not waive any rights or grant any jurisdiction to said authorities.
 - e. The Order does not grant servitude or other purported rights to said authorities to any Soil, chattels, Land, property, or Rights to Land or property in any form which have been donated, bequeathed, bought, or contracted to the Order or Society.
 - f. The Order is not a Public commercial entity and shall forever remain private and not engage whatsoever in commerce, and whereby:
 - i. The Order and Society are unique Lawful entities. This means they are not aggregate Corporations; not created by a Stature; and there is no Board or Officers.
 - ii. The formation of statutory entities shall not attach any contractual nexus or numeric identifier to the Order directly, which might be construed to impair the private nature of the Order or its superior authority over any entity of inferior jurisdiction.

- g. The Order explicitly denies any adhesion or grant of jurisdiction to any other lesser or inferior body for any arbitration or claims, whether commercial, civil, or otherwise, and whereby:
 - iii. Any attempt to establish jurisdiction in any public commercial administrative tribunal shall be properly abated by the filing under special appearance of a copy of this Reclaration, and whatever appropriate Writ is issued by the Tribunal of Petitions and Writs of the Justice.
 - iv. Venue and Jurisdiction for any claims against the Order or Society shall be the Justice.
- 5. The Overseer shall have all rights necessary to fulfil the purpose of the Order and to conduct any lawful private affairs, and whereby:
 - a. The Authority and Powers of the Overseer shall be construed as general powers.
 - b. The Overseer is empowered to make ALL decisions and take ALL actions deemed proper and necessary to maintain the mission and operations of the Society.
 - c. The Overseer must preserve and protect and grow the assets of the Order for the mutual and beneficial interests of the Society and those who choose its services.
 - d. The Overseer is authorized to establish trusts and enter Contracts either statutory or private in nature, for the purpose of holding and protecting and enhance the assets of the Order. This includes to establish a Private Contract Association for purposes of enrolling members into said association for whatever purpose is determined by the Order Holder.
 - e. The Overseer or designated agents of the Order can increase the assets and wealth of the Society by engaging with activities such as buying and selling or leasing land; buying or selling mortgages, securities, bonds, notes, commodities, or precious metals and minerals; opening trading establishments; allocating funds derived from any source for charity, religion, education, research, or other purposes; pledging the assets or property of the Order; and hypothecating assets or property.

- 6. The Overseer and any other authorities appointed by the Overseer shall serve without Fidelity Bonds.
- 7. ANY and ALL liabilities that arise from enacting the duties of Overseer shall not in any manner jeopardize the real or personal property of the man Russell Paul Arthur - except for a wilful breach of trust, and whereby:
 - a. For any losses the Overseer should suffer for any reason through services, the Overseer shall be reimbursed from the Order's assets or income to the same extent as would non-interested parties.
- 8. Every real or fictional entity that contracts or deals with the Order or Overseer or Society, and whereas such a debt, claim, or judgment arises from said matters, the real or fictional entity shall look only to the funds and property of the Order for payment or satisfaction thereof.
- 9. No Fiduciary Party or Agent of the Order shall ever be personally liable for or on account of any contract, debt, tort, claim, damage, judgment, or decree arising out of the affairs of the Society, except in cases of purposeful neglect, unlawful acts, or wilful malfeasance in the carrying out of designated duties for the purposes of the affairs of the Society.
- 10. The Overseer as well as any agent appointed thereby, shall always seek to preserve the rights and assets of the Order and Society against waiver or any other potential loss.
- 11. No commercial contracts or benefits can be attached to the Order if and when the Overseer states a lack of consent and/or lack of acceptance thereof.
- 12. The Order is established with a Covenant of Silence. Said Covenant is between said Office and the members of the Society, and whereby:
 - a. The Overseer is required to affirm his or her acceptance of the aforesaid Covenant until his or her death.
 - b. Each Order Holder agrees to set off for liquidated damages by selfassessment (in the nature of Self-Confession of Judgment and Self-Executing Contract), the amount of Ten Million (10,000,000) Pounds of Silver, or equivalent for each occurrence of a breach.
 - c. This amount of applied liquidated damages is and shall be transferable to any person, whether corporate or living man or woman in individual

capacity, who attempts to forcibly compel the Order Holder or other individual holding order for the Society to reveal the private documents, private affairs, or affairs of the Society against his or her will in maintaining said Covenant of Silence.

- d. No Living Being, Person, Corporation, or other entity can inquire into the authority, expediency, propriety, validity, or necessity of the Order to make or perform any transaction whatsoever, or to account for the application or disposition of any money or other property transferred to the Overseer or Order thereof on any account.
- e. The articles and matters of the Order shall remain private and not in any way be subject to subpoena or other demands from the public. Therefore *not* subject to demand, claim, devise, or other publicly originating process.
- f. All breaches of privacy and any Breach of Trust by public servants as the administrative trustees of the Public Trust, shall be subject to the above established sum as penalty for breach of the Covenant of Silence.
- g. Any actual or attempted trespass on the Covenant of Silence shall be immediate cause for issuance of a True Bill accompanied by a Selfexecuting Power of Attorney (Tacit Procuration) and Confession of Judgment to be presented to the trespassing party or parties for payment of liquidated damages. The herein Reclaration the Overseer shall serve as the only notice of the self-executing nature of such liquidated damages.
- 13. The Order and Society and its assembled members do hereby give notice that we are at peace with ALL Nation States, Corporate or Sovereign bodies in this world. We proceed forward as non-belligerents, non-combatants, and neutral in the public, whilst preserving and protecting all unalienable, substantive, and inherent rights of Self-Determination and private capacities.
- 14. The Order and Society is established and domiciled within the sovereign authority and jurisdiction of the Justice, and ALL Postal Matters must sent thereto.



ACCEPTANCE OF OVERSEER

LET IT BE KNOWN TO ALL PRESENT that I, **Russell Paul Arthur** to accept the position and duties of Overseer, and as the Holder of the Order of Overseer.

I do hereby affirm under Oath that the facts of this Reclaration and Decree are true and correct and complete, and I bring forth this Notice to the Public, and whereby said notice and is Sealed On this Eighteenth Day of the Eighth Month in the year commonly known as Two Thousand Twenty-Three.
